Members absent: None

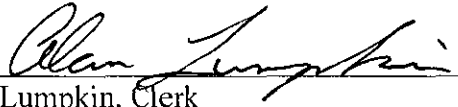

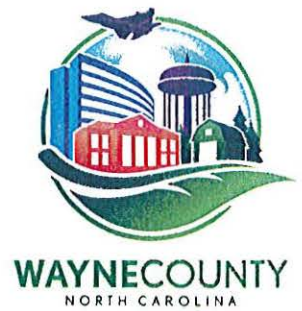
No one appeared to appeal the value of their property on this date.

At 8:45 a.m., the meeting of the Wayne County Board of Equalization and Review was recessed.

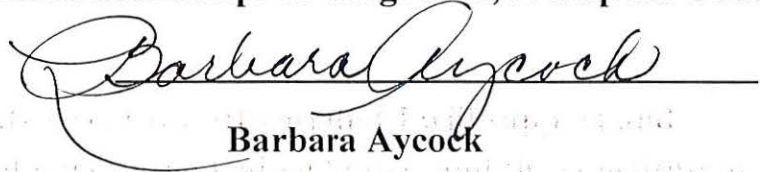
