Briefing Session

During the scheduled briefing and prior to the regularly scheduled meeting, the Board of Commissioners held an advertised briefing session to discuss the items of business on the agenda.

The briefing began at 8:00 a.m. with County Manager Craig Honeycutt reviewing the agenda. He added the following:

9:34 A.M. Public Hearing to Receive Public Comments on the Proposed Voter District Plan for the Wayne County Board of County Commissioners

Staff Attorney Andrew Neal reviewed the proposed 2020 Voter District Plan for the Wayne County Board of County Commissioners, attached hereto as Attachment C.

As no one appeared for comments, Chairman George Wayne Aycock, Jr. closed the Public Hearing at 9:49 a.m.

Upon motion of Vice-Chairman Freeman Hardison, Jr., the Board of Commissioners unanimously adopted Resolution #2021-38: A Resolution Redefining Wayne County Board of Commissioners and Board of Education Electoral District Boundaries.

Discussion of Wayne County Mask Mandate Policy, as Requested by Commissioner Chris Gurley

Commissioner Chris Gurley discussed the COVID-19 numbers coming down.

Upon motion of Commissioner Gurley, the Board of Commissioners approved removing the Wayne County mask mandate in all Wayne County facilities, by a vote of four to three, effective immediately. Voting against the motion were: Commissioner Bevan Foster, Vice-Chairman Freeman Hardison, Jr., and Commissioner Antonio Williams.

Commissioner Bevan Foster expressed his objections to the mandate being pulled and questioned where Commissioner Chris Gurley obtained his information on the numbers.

Commissioner Antonio Williams expressed his concerns over removing the mandate being prematurely revoked.

Commissioner Chris Gurley cited the Wayne County Public Schools Board of Education and a local health expert, for his research behind the decision.

9:56 A.M. Public Comments

Register of Deeds Constance Coram spoke to the Board and read from a report and complained about numerous matters involving the Register of Deeds office. Following her time limit of three minutes and approximately one additional minute, Chairman George Wayne Aycock, Jr. asked Ms. Coram to leave the podium due to her time being up. Ms. Coram refused to leave, continued to read her report very loudly, and had to be escorted out by Captain Ray Brogden and Sheriff Larry Pierce, despite Commissioner Bevan Foster asking her to leave as well.

Ms. Sylvia Barnes spoke in favor of evening meetings and thanked the Board for scheduling one each quarter in 2022.

With no one else signed up to speak, Public Comments were closed at 10:05 a.m.

County Manager's Report

County Manager Craig Honeycutt discussed the new vaccine site on Grantham Street and read an email from Vaccine Site Director Adam Wolfe. He also reminded the Board of the State of the Community event, at which Chairman George Wayne Aycock, Jr. will speak. Mr. Honeycutt said the Chamber of Commerce's Legislative breakfast had been cancelled again and said the County offices would be closed for Veterans Day.

Board of Commissioners Committee Reports

Commissioner Barbara Aycock attended the Crime Stoppers dinner, as well as the Industry Appreciation dinner, and she congratulated the Seegars family for winning Industry of the Year. She discussed a presentation to the Tourism Board by Rob Wooten for changes to the former ECAP location. Commissioner Aycock thanked the staff for their work on the census.

Commissioner Bevan Foster discussed the "Please silence your cellphones" note on the agenda form and asked to be given the dates of when the wording was first put on the agendas.

Commissioner Joe Daughtery had no comments.

Commissioner Antonio Williams discussed the evening meetings and the lack of media coverage regarding Mount Olive's sewer problems.

Commissioner Chris Gurley attended the Industry Appreciation dinner and congratulated the Seegars family for winning Industry of the Year. He also discussed shortages in supplies and the nation's dependency on other countries for goods. He also mentioned the need for volunteers with the fire service and discussed ongoing training with the volunteer departments.

Vice-Chairman Freeman Hardison, Jr. discussed properties owned by the County and the need for neighbors to be vigilant to trespassers. Commissioner Hardison shared the Goldsboro-Wayne Transportation Authority's Veterans Ride Free event and thanked the Executive Director Don Willis. He promoted vaccinations and boosters and also discussed the media's handling of the meetings, asking them to educate the readers, and agreed with Commissioner Williams on the sewer issues in Mount Olive.

Chairman George Wayne Aycock, Jr. spoke of the importance of attending the Veterans Day Parade, particularly this being a military community, and stated he had missed several events due to attending the interviews for Wayne Community College's President search. Chairman Aycock apologized to the Board for his actions on the allotted time for Public Comments, but stated he was following procedures. He also apologized to the Sheriff for putting him in the middle of the situation.

Adjournment

At 10:21 a.m., Commissioner George Wayne Aycock, Jr. adjourned the meeting of the Wayne County Board of Commissioners.

The Maxwell Center currently holds the following ABC permits: sale of malt beverage on premises, unfortified and fortified wine on premises, and convention center mix beverages. When the original permit was submitted to the ABC board for approval, previous Chairman William Pate, previous Vice-Chairman A. Joe Gurley, III, Craig Honeycutt, and James Wade were listed as officers for permitting purposes. ABC permits are renewed on an annual basis which results in a discrepancy in the named officers on the permit due to change in board chairmanship. To assure efficient renewal of future Maxwell Center ABC permits, Staff is requesting that the Board delegate its ABC permit renewal authority to the Maxwell Center Director and modify the listed officers to the County Manger and Maxwell Center Director. This will alleviate future inconsistencies which may arise due to changes in Board chairmanship and/or membership.

**RESOLUTION #2021-38: A RESOLUTION REDEFINING WAYNE COUNTY
BOARD OF COMMISSIONERS AND BOARD OF EDUCATION ELECTORAL
DISTRICT BOUNDARIES**

WHEREAS, the Wayne County Board of Commissioners currently consists of seven members with six members elected by individual districts and one at large member;

WHEREAS, this board structure was approved by a three judge panel of the United States District Court for the Eastern District of North Carolina, Raleigh Division in a case entitled Wayne County Branch of NAACP et al. Plaintiffs vs. Wayne County, North Carolina. et al. Defendants (5:1986-cv-1091); and

WHEREAS, the existing plan has been followed since the entry of the Consent Order in the United States District Court for the Eastern District of North Carolina, Raleigh Division; and

WHEREAS, the Wayne County Board of Education utilizes the same electoral districts as the Board of Commissioners pursuant to the plan adopted by the Wayne County Board of Commissioners under NCGS § 115C-68.1 on September 17, 1991 entitled “Plan to Provide for the Merger and Consolidation of the Goldsboro City Board of Education and the Wayne County Board of Education and to Establish one Administrative Board of Education for all the Public Schools in Wayne County” which is recorded in Book 1318 at Page 279 of the Wayne County Registry; and

WHEREAS, the 2020 Decennial Census data shows there is an inequality of population among all of the districts such that a failure to redistrict would cause existing districts to be in violation of current federal and state law; and

WHEREAS, North Carolina General Statute §153A-22 provides that when such inequality of population among electoral districts exists, the Board of Commissioners may, by Resolution, redefine the electoral districts; and

WHEREAS, Wayne County staff has produced a map containing an equitable population balance among the six districts entitled “2020 Commissioner District Map; Wayne County, North Carolina” which is attached to this Resolution and incorporated herein by reference; and

WHEREAS, on November 2, 2021 the Wayne County Board of Commissioners held a public hearing to receive comments on the proposed electoral districts; and

WHEREAS, pursuant to North Carolina General Assembly Session Law 2021-56, any county which is divided into electoral districts for the purpose of nominating or election persons

to the board of commissioners must review and revise its electoral districts on or before November 17, 2021.

NOW, THEREFORE BE IT RESOLVED by the Wayne County Board of Commissioners that:

- 1. Based upon the 2020 Decennial Census there is an inequality of population in the existing Board of Commissioner Districts and redistricting is necessary pursuant to NCGS §153A-22 and applicable federal law.
- 2. The current electoral district boundaries for the Wayne County Board of Commissioners and the Wayne County Board of Education are hereby updated by this Resolution based on the 2020 Wayne County Census data as depicted in the attached map entitled “2020 Commissioner District Map; Wayne County, North Carolina” and further defined by 2020 US Census Blocks as follows:

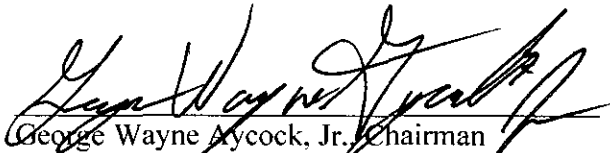

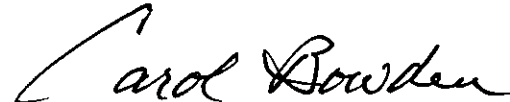
